SIGN PERMIT APPLICATION SUBMISSION REQUIREMENTS & GUIDELINES

GENERAL SIGN PERMIT INFORMATION

- All signs erected in the Village of Fairport require a sign permit.
- All structures that have more than one sign and all ground signs shall require a sign site plan to be approved by the Village of Fairport Planning Board. 36 square feet total amongst 2 signs is allowed with an approved sign site plan. Signs not conforming to the Village sign code can apply to the Fairport Zoning Board of Appeals for a variance.
- A permit fee is \$2.50 per square feet or a minimum of \$40.00.
- The sign compliance certificate cost is \$25.00.
- An electrical inspection is required if lighting is installed.
- Insurance is required from the installer of the sign.

Please Submit for all Application Types:

- completed sign permit application
- color illustration/rendering of proposed sign with dimensions depicted
- a brief description of the sign composition and lighting proposed with color pallet and how it will be affixed to the building
- photo of existing structure showing proposed location(s) of sign(s)

VILLAGE LANDING SIGN PERMIT INFORMATION

- The following fees apply to approved signs:
 - Fascia – 10 square feet - \$40.00
 - Pylon – 6.73 square feet - \$40.00
 - Atrium – 1.01 square feet - \$40.00
 - Sign compliance certificate - \$25.00

PACKETTS LANDING (Building 400) SIGN PERMIT INFORMATION

- The following fees apply to approved signs:
 - Hanging – 2.25 square feet per side- \$40.00
 - Fascia – 16 square feet- \$40.00
 - Sign compliance certificate- \$25.00

BUSINESS ADVERTISING DEVISE (BANNER) INFORMATION

- AT A BUSINESS LOCATION: A banner permit is valid for 30 days. No more than 3 permits may be issued to any establishment or address during a twelve month cycle.
- AT THE 4 CORNERS/FENCE LOCATION: A banner permit is valid for 14 days and maybe be erected two weeks prior to an event and must be removed the day after the scheduled event.

- There is a \$20.00 fee for all Business Advertising Devices.
